Graduate Course Change Requests (3)

Department: School of Physical Therapy

Course Number and Title: PT 710 Introduction to Human Movement

Rationale: Better alignment of learning of surface anatomy palpation along with structural anatomy taught in this semester

Course Description (old): Lecture and laboratory introducing students to basic histology of connective, nervous, epithelial and muscle tissues utilized in human movement, and biomechanical terminology and principles used to describe and analyze movement.

Course Description (new): Basic histology of connective, nervous, epithelial and muscle tissues utilized in human movement Surface Palpation Skills.

Catalog Description (revised): Lecture and laboratory introducing students to basic histology of connective, nervous, epithelial and muscle tissue utilized in human movement and to palpations skills of tissues utilized in movement.

Department: School of Physical Therapy

Course Number and Title: PT 711 Human Movement I

Rationale: Description Change - In order to pair the palpation skills necessary for examination with the anatomy being covered in PT 700 Gross Anatomy for Physical Therapists, we are moving palpation skills forward from PT 711 Human Movement I to PT 710 Introduction to Human Movement. To make room for this addition to 710, biomechanical terminology that was covered in PT 710 is being moved to PT 711. Credit Hour Change - After running the course for the first time, it became obvious to faculty that there were insufficient laboratory hours to cover material that is required in this course. Therefore, we wish to add 1 credit hour to PT 711 Human Movement I. The hour will be taken from PT 761 Evidence Based Practice I, which in the judgment of the SOPT faculty, does not require as many hours as it originally had been assigned to cover the material listed in the course syllabus (a Course Change Form is being submitted as this time for this change). Therefore, the total credit hours in this semester and in the Doctor of Physical Therapy Program curriculum will not change.

Course Description (old): Biomechanical principles, muscle actions, joint mechanics, joint segments and whole body movement pattern analysis, and mastery of surface anatomy and palpation skills necessary for differential diagnosis of movement dysfunction

Course Description (new): Biomechanical terminology and principles, muscle actions, joint mechanics, joint segments and whole body movement pattern analysis, and mastery of human movement observational analysis skills necessary for differential diagnosis of movement dysfunction.

Catalog Description: Biomechanical terminology and principles, muscle actions, joint mechanics, joint segments and whole body movement pattern analysis, and mastery of human movement observational analysis skills necessary for differential diagnosis of movement dysfunction.

Credit Hours: 3 credits to 4 credits

Department: School of Physical Therapy

Course Number and Title: PT 761 Evidence Based Practice I

Rational: After teaching 761 this semester, it became obvious to faculty that 2 credits are not required to cover the material that is intended to be covered in this 7 week course. Therefore 1 credit hour is being removed and moved to PT 711 Human Movement I which does require more time to cover material in that course (Course change form for PT 711 is being submitted at this time). Therefore, total credit hours for this semester and for the DPT Program curriculum will not change.

Course Description (old): This course focuses on the introduction to physical therapy clinical decision making and diagnosis including clinical hypothesis development, utilization of information sources, and use and interpretation of research methodology relevant to clinical practice and research.

Course Description (new): no change

Credit Hours: 2 credits to 1
