

## MEMORANDUM OF UNDERSTANDING BETWEEN MARSHALL UNIVERSITY AND ALICE LLOYD COLLEGE LEADING TO A DOCTOR OF PHARMACY DEGREE (Pharm.D.)

School of Pharmacy

Marshall University and Alice Lloyd College, in order to promote and facilitate the educational opportunities afforded students interested in pursuing a pharmacy education, establish this memorandum of understanding (MOU). This MOU stipulates a series of courses that, when satisfactorily completed by Alice Lloyd College students, will meet the Pharm.D. degree's prerequisite requirements and facilitate student enrollment within the Marshall University School of Pharmacy.

Marshall University and Alice Lloyd College agree to monitor and support the provisions of this agreement to ensure the consistency, quality, and transferability of students interested in pursuing a Pharm.D. degree. Marshall University and Alice Lloyd College agree to coordinate changes in the course content and/or requirements for any courses listed in the MOU for the purpose of ensuring continued comparability between the courses offered on each campus. Marshall University and Alice Lloyd College agree to renegotiate this agreement when changes to the Pharm.D. Curriculums occur or when changes in the graduation requirements for either institution become necessary. This process will be the responsibility of the appropriate deans at both institutions.

Students pursuing the Pharm.D. degree through the memorandum of understanding will be bound by the curriculum description (Appendix A) in effect at the time they are officially accepted into the Pharm.D. program. The attached curriculum sheets dated February 22, 2017 will be in effect until officially changed and agreed upon by both institutions

## APPENDIX B: PROCESS

Students attending Alice Lloyd College who elect to pursue the Marshall University Pharm.D. degree program will take any/all of the courses listed in Appendix A through Alice Lloyd College. Upon transfer to Marshall University School of Pharmacy, the listed courses will be accepted by Marshall University as meeting the required pre-pharmacy course requirement indicated for that course.

As part of the articulation agreement, MUSOP agrees to give guaranteed admission during each admission cycle to two or more<sup>1</sup> Alice Lloyd College students who select to transfer to the Pharm. D. program and meet the minimum transfer requirements. The minimum transfer requirements are:

- 1. Selection for receipt of guaranteed admission<sup>2</sup> by the appropriate Alice Lloyd College Dean or group. Alice Lloyd College will submit a list of students deserving guaranteed admission to the MUSOP Office of Student Affairs prior to August 1 of each year; preferential consideration will be given to Alice Lloyd College students applying after Early Decision who meet the requirements stated in 2 and 3 below;
- 2. Minimum grade of 3.4 at Alice Lloyd College for all courses listed in the memorandum of understanding;
- 3. PCAT ≥ 50 and completed within prior 12 months; PCAT scores submitted to Marshall University School of Pharmacy through PharmCAS;
- 4. Completed application for **Early Decision** by the stated deadline through the online Pharmacy College Application Service (PharmCAS, at <a href="http://www.pharmcas.org">http://www.pharmcas.org</a>) as;
- 5. Submission of the Marshall University School of Pharmacy supplemental application and all required applications fees by the date of on-campus interview;
- 6. Successful completion of an on-campus admissions interview.

The MUSOP admission cycle is a three-stage process that includes initial applicant screening, on-campus interview, and the admission decision. Approximately 40% of applicants will be offered an on-campus interview during any admissions cycle. All students completing prerequisite course work through Alice Lloyd College who meet or exceed the minimum requirements as identified above will receive preferential treatment during the MUSOP admission cycle. Receipt of preferential treatment absolves Alice Lloyd College students who meet the requirements of this articulation agreement from the initial applicant screening and guarantees the student an on-campus interview.
