Marshall University Facility/Land Use Master Plan Update/Revision As of September 29, 2011

Ten Year Master Plan Background

The current Facility/Land Use Master Plan was submitted and approved by the Marshall University Board of Governors on September 10, 2003. The Facility/Land Use Master Plan was submitted and approved by the West Virginia Higher Education Policy Commission on December 5, 2003.

The Five-Year Facility/Land Use Master Plan Update was submitted and approved by the Marshall University Board of Governors on January 23, 2008 and submitted and approved to the West Virginia Higher Education Policy Commission on May 2, 2008.


At the April 28, 2011 Meeting of the Marshall University Board of Governors, the Board approved a Capital Project List for inclusion in the New Bond Issue. Those projects were as follows:

- Multi-Floor Parking Structure
- Soccer Stadium Complex
- Biotechnology Incubator/Applied Engineering Complex
- Fine Arts Incubator/Visual Arts (Stone & Thomas Renovation)
- Indoor Athletic Complex
- Modern Academic (High Technology) Instructional Facility
- Land Acquisition and Building Demolition

All of the above projects with the exception of the *Multi-Floor Parking Structure and the Soccer Stadium Complex* were on the Five-year Update of the Facility/Land Use Master Plan and shown on the projected Capital Project List for FY 2008-2013. We ask that the Board approve these revisions.

Location changes requested to complete the revised plan will be the relocation of the Fine Arts Incubator/Visual Arts from its Fifth Avenue (adjacent to the Joan C. Edwards Fine and Performing Arts) to the downtown Stone and Thomas location across from Pullman Square. The proposed location for the Modern Academic (High Technology) Instructional Facility is located on the south-west corner of Third Avenue and 18th Street. In addition, the expanded concept of the Indoor Athletic Complex will include the Academic Support Center and the Sports Medicine Translational Research Center.
